CONDITIONS AND RESTRICTIONS

A. The movement of vehicle and load upon said highway shall be between sunrise and sunset only. Permits are not valid on Saturdays, Sundays, nor during the period at 12 noon on the day preceding and continuing until 12 noon of the day following every legal holiday.

B. The movement shall not impede other traffic in an unreasonable manner and at no time shall other traffic be blocked from use of the highway. Vehicles and loads shall not be parked on the roadway day or night.

C. Applicant shall be responsible for any damage caused to wires, mailboxes and trees on the roadway, and shall reimburse the owners or persons in charge for any property damage caused by the moving of said vehicle or load, and shall save harmless and indemnify the Jackson County Road Commission from all suits, claims, damages, and proceedings of every kind arising out of the presence on and use of the highway by said vehicle and load.

D. Vehicles shall be registers as required by the Michigan statute and will not violate any statute or valid ordinance, rule, or regulation by any State agency or subdivision of the State. Vehicles are to comply with all statutory provisions as to other permits, licensing motor vehicle equipment and operation.

B. The driver of the vehicle shall carry a permit cab card in the vehicle to which it applies and shall have It available for inspection by any police officer or agent of the Jackson County Road Commission.

F. Permits are automatically invalidated by the violation of any of the conditions specified by the terms of the permit or by false information given on the application. Failure to comply with the conditions of this permit shall be just cause for the immediate suspension or revocation of all permits and the operator and/or owner of the vehicle subject to arrest.

G. If the equipment is to be moved on any State highway or city street, permission must be obtained from the appropriate authorities.

H. The applicant may be required to deposit a reasonable Inspection fee and to furnish a good and sufficient bond to cover any damage that might occur to roads. D

J. Applicant must present evidence that at least the following insurance coverage **with Jackson County Road Commission listed as additional insured** is in full force and effect on each vehicle while operating on the public roadway under special permit:
